## Workshop on Transnational Co-operations between Development Partnerships

In order to find and get to know the right partner, the PEI – together with the ISL (co-ordinator of another German DP) – invited various groups to an international workshop entitled „Integration of Disabled People into the Labour Market“. This workshop took place at the Steigenberger MAXX Hotel and the Paul-Ehrlich-Institut on 24<sup>th</sup> and 25<sup>th</sup> February 2005. Altogether, 22 participants coming from 10 DPs and 7 countries (Germany, France, Italy, Ireland, Polen, Sweden, Slovenia) took part. The meeting was located at the Steigenberger MAXX Hotel and the external office of the PEI and organised by the PEI EQUAL working group.

After an introduction of all DPs the possibilities to co-operate were discussed; first in a large group, then in smaller ones.

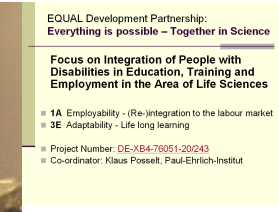

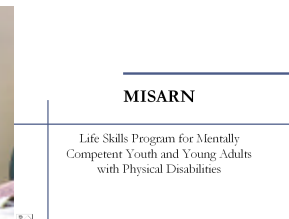
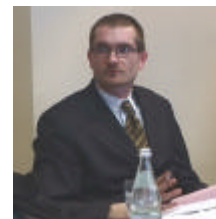
